If this account is not paid in accordance to terms and conditions the applicant promises to pay all costs of collection, including reasonable attorney fees, whether or not a law suit is commenced as part of the collection process. The undersigned does hereby release and agree to save harmless SAH, LLC its employees and agents from any and all claims which may arise as a result of delivery made upon private property, or past the curb. *Notice: under the mechanic's lien law (KRS 376.010), any contractor, subcontractor, laborer, supplier, or other person who helps to improve your property but is not paid for his work or supplies has a right to enforce a claim against your property. That means that, after a court hearing, your property could be sold by a court officer and the proceeds of the sale used to satisfy the indebtedness.
